		Check industry memberships and affiliations - Are they members of reputable organizations, such as National Fire Protection Agency (NFPA) and are they NICET-certified?
		Review company reputation and history - Have you spoken to peers or industry leaders who have direct experience with the vendor?
02	Range of Services	Comprehensive suite of capabilities - Will they be able to save you resources and time by providing end-to-end support, such as design, installation, maintenance, monitoring?
		Ability to handle all fire and life safety systems - Can they cover multiple systems so that you don't need to seek out different vendors for alarms, sprinklers, and suppression systems?
		Customized solutions tailored to your needs - Are they willing and able to consider your unique needs and develop a solution that is best for your business?
03	Experience	Years of experience in the industry - Are they an established business

Years of experience in the industry - Are they an established business with demonstrated reliability and stability?

Expertise in your specific building type and industry - Do their \checkmark technicians have the know-how to mitigate risk in specialized environments, such as educational or healthcare facilities?



Knowledge of local, state, and federal fire safety regulations - Can they offer localized support with knowledge of intricate regulations and requirements?

04	Integration Capabilities	 Ability to integrate safety systems - Do they provide testing on multiple systems to ensure seamless functionality? Proven track record of successful system integrations - Can they offer examples of how they've aligned disparate systems to function together reliably?
05	Quality of Service	Single point of contact for all services - Will you be thrown to an operator or have one point of contact you can text or call?
		Availability of local technicians and support - Do they have a local number for you to call and technicians close by in case of emergencies?
		Consistent and reliable service delivery - Do they have experienced technicians and low employee turnover rates?
		24/7 emergency support and response times - Can they guarantee 24/7/365 monitoring, alerting, and service?
06	Technological Advancements	Utilization of the latest fire and life safety technologies - Does the company stay on top of the latest innovations and available system upgrades?
		Expertise in various systems - Can they service your existing systems and aid in future planning for upgrades and maintenance?





07	Scheduling and Billing	Easy scheduling and coordination of service visits - Are they responsive and timely in scheduling service visits? Better yet, do they proactively reach out when it's time for maintenance?
		Transparent pricing structure - Do they clearly explain their pricing structure and all costs and fees?
		Simplified billing processes - Can they ensure timely, accurate billing?
		Options for service contracts or bundled services - Can they alleviate your vendor management workload by providing bundled services?
08	References and Reviews	Positive testimonials from existing customers - Have they provided customer references in the same or similar industries?
		Case studies showcasing successful projects - Do they have case studies on their website? Are any of those customers on their reference list?
		Online reviews and ratings - Do they have a positive online presence? Do they have an active LinkedIn presence?
09	Compliance and Reporting	Comprehensive compliance with all regulations and standards - Are they experts in national and local requirements?

Detailed and timely inspection and maintenance reports - Do they consistently complete reports on time and place them in the proper place for inspectors?



Assistance with compliance documentation and audits - Do they provide accurate, detailed reports with clear recommendations for any necessary repairs or upgrades?

Training and Support

Availability of training programs for staff - Do they offer in-person and web-based training so that your staff understands basic system operations?

Ongoing support and education on fire and life safety protocols - Do they proactively provide updates as standards evolve?

Resources for continuous improvement and updates - Are they experts in fire and life safety, alerting you to future needs and making recommendations for planning?
